The Director of Real Estate for Coalition Homes is an experienced affordable housing development and property management professional with a graduate degree, or minimum of 5 years experience with a relevant professional certificate in the field. The responsibilities of the Director of Real Estate require the ability to meet the diverse demands of the position, while maintaining a strong commitment to the social goals of special needs housing combining permanent housing with supportive services. The director will supervise two staff and be responsible for an annual budget in excess of \$800,000.

Property Management Qualifications:

The candidate must have 2 years direct experience in residential property management, encompassing:

- Accounts payable, accounts receivable, general ledger, annual budgeting and budgeting variance reports
- Tenant certifications and re-certifications typical of tax credit or Section 8 affordable housing
- · Compliance reporting and site audits
- Procedures for rapid lease-up

- Application of fair housing laws
- Organization of tenant files and property binders

Housing Development and Asset Management:

The candidate will be the asset manager for our housing portfolio units and be responsible for a small-scale acquisition program. The candidate must be self-directed and collaborative with the capability to:

- Produce annual operating budgets, and review budgets. Work with Chief Financial Officer on a range of budget, loan compliance and audit responsibilities.

- Negotiate rent levels and annual rent increases with HUD, the Montgomery County Housing Opportunities Commission and other public funders based on prevailing rent levels in market.

- Represent the ownership's interest on insurance claims, regulatory compliance issues and lender monitoring inquiries. Supervise the work of outside professional consultants as necessary.
