- 7. Latest data from #HIT2023 shows jurisdictions are responding to the challenge of creating more #housing Across all 20 areas, 25,466 new affordable rental units were created in 2022, meeting the region's goal of 25,000 new units for the first time since the launch of the tool.
 - Only 2,507 of those units, however, are designated #affordablehousing only 235 of which are reserved for residents earning 30 percent or less of the area median income. This means there is still a long way to go! But it is crucial to use the HIT to set a baseline in order to know where we go next! Learn more at: https://bit.ly/HIT23
